- Previously reported number of underlying securities was 20,000. 6,666 shares of this grant were exercised on June 3, 2004 and 6,667 shares of this grant were exercised on November 12, 2004. On January 21, 2005, the common stock of NCR Corporation split 2-for-1, with the result that the remaining number of securities of 6,667 increased to 13,334, all of which are being exercised at this time.
- The option vests in 3 equal annual installments beginning on 07/29/2003.
